

SITE CONTEXT



This site is currently zoned CN2d (Commercial Neighborhood 2, subject to Design Review), with a small corner designated as R1 (medium density multi-dwelling residential). The Phase 1 core/shell remodel of the building (Land Use Review #LU 15-205150 DZM) was approved on 11/16/2015. The permit review process included structural analysis for the proposed floor addition in Phase 2. This addition exceeds the current FAR and height. Limitations and a Comprehensive Plan Amendment/Zone change will be submitted concurrent with the Design Review submission for this proposed addition. The DR decision will be predicated upon approval of the CP/ZC to allow the proposed height and DAR increases.









PH2 - CANOPY 1" = 1'-0"


