Happy New Year! As you know, the Design Overlay Zone Assessment (DOZA) is moving into its detailed recommendations phase. The consultant team has prepared a "Preview Draft" Recommendations for your review (attached). They are currently working on a more graphic-rich set for release on January 18, but the content will remain unchanged from this draft.

Next Friday, January 13, from 12-4 pm, Design Commission will hold a workshop to discuss the contents of these Recommendations. To assist in your deliberations, please review the enclosed document. Because the workshop will not allow for every topic to be covered in depth, a quick survey will be sent to each of you to identify your highest priorities for this discussion. The survey will also be an opportunity for you to comment on any of these Recommendations themselves.

Your feedback on the Recommendations as well as the feedback from the newly formed subcommittee of the Planning and Sustainability Commission is the topic of a joint briefing tentatively scheduled for February 9 with the consultant team. The PSC subcommittee will also engage in a survey and workshop to hone in on their comments in the coming weeks.
