SUBJECT: CC2035 Work Session on January 24, 2017

The attached packet includes a set of decision tables and memos that staff will walk you through at the work session on January 24, 2017. As you will note, the packet includes a number of items that were on the January 10, agenda but you asked us to defer to future meetings. The topics on this work session agenda include a Cost Analysis, Green Buildings (ecoroofs and bird safe glazing), policy amendments including some related to family compatibility, and part one of a set of amendments related to the bonus and transfer system. All of the materials for the work session are posted on the BPS website except for the Cost Analysis memo which will be posted later next week.

The decision tables referenced in the agenda indicate which items are currently tagged for PSC discussion. At the last work session, we will ask the PSC to vote on all of the volumes as a package.
