Appoint Jenny Kim to the Home Forward Board of Commissioners (Resolution)

WHEREAS, the City Council adopted Resolution 22081 on December 11, 1941 establishing the Housing Authority of Portland according to Oregon Revised Statute 456.095 through 456.720; and

WHEREAS, Commission members must be appointed by Resolution as directed by Oregon Revised Statutes 456.095(2) and ORS 456.100(4); and

WHEREAS, Jenny Kim is currently a principal consultant at Presley and Kim, LLC. Kim has more than 20 years of experience developing and implementing effective strategies for non-profit and civic organizations; and

WHEREAS, she serves as the Executive Director of the Korean American Coalition National Board and as a member of the City of Portland's Public Involvement Advisory Council; and

WHEREAS a dedicated community advocate, she is interested in ensuring that the allocation of Portland's affordable housing supply remains an efficient and equitable process; and

WHEREAS, Mayor Ted Wheeler has recommended Jenny Kim for a vacant seat for a limited term expiring January 22, 2018.

NOW, THEREFORE, BE IT RESOLVED that the City of Portland appoints Jenny Kim to the Home Forward Board of Commissioners for a limited term expiring January 22, 2018.


