### EXECUTIVE SUMMARY

The Commission found the revised massing strategy to be strong and responsive to both neighborhoods. The shared "DNA" design concept among the three buildings was supported, while noting materiality could be where the departures occurs. More articulation, detail and focus is needed at the northern plaza as the design progresses to ensure the public space flanked with residential units is well resolved for all users.

### Context

- Support was expressed for the height differential proposed.
- The refinements and playful design elements that result from the 5 over 2 construction type is appreciated.
- Very thoughtful how the project weaves and connects to the context of Phase 1 and the topography of the site.
- The south building, which is the pivot between Phase 1 and the Sullivan's Gulch neighborhood, is doing a great job of turning the corner. It responds well to the neighborhood scale to the east and open spaces of Phase 1 to the west.
- Great job in knitting together two disparate neighborhoods.
- The success of the south building is critical.

### Public Realm

- The ground floor program (strong retail corners, type & location of residential, active lobby at the northern end) makes sense and works really well.
- For the Type 3 review there will be a lot of discussion about the northern plaza as it has the potential to be the "bells and whistles" for the project. The focus will be on the public vs. private nature of the plaza, articulation of the space, the use of public art, etc.
- One Commissioner expressed that public art was not necessary given the scale of the northern plaza space.
- More articulation is needed at the northern plaza.
- Look at how to make the northern plaza area defensible.
- The northern plaza needs to be designed so that people feel comfortable moving through the space.

## Quality and Permanence

- Support was expressed for the "cousin" design concept.
- The images presented suggest a ton of flexibility and you might end up with long, lost cousins, which is fine.
- Perhaps using material on larger volumes differently could be a way to differentiate the buildings.
- Consider shifting materials slightly from the south building to the northern buildings to respond to the change in context.
- The potential materials identified seem more appropriate and simpler than those on Phase 1.
- All of the materials identified (cementitious, metal etc.) are supported, however detailing will matter a lot.
- The design concept is really rich for accepting balconies and Juliettes for visual and physical access.
