

ORDINANCE No. 174633

*Extend Legal Services Agreement with Reeve Kearns PC (Ordinance, amend Agreement No. 32278)

The City of Portland ordains:

Section 1. The Council finds:

1. Due to scheduling and staffing limitations, the City required the services of outside legal counsel to assist in the matter Robert F. Lishey v. City of Portland, Case No. CV99-84-JO, Risk No. G97-8016-01 SK..
2. Tracy Reeve of Reeve Kearns PC (Counsel) agreed to provide these services by Legal Services Agreement No. 32278 dated May 21, 1999 and increased by Ordinances 173916 and 174461 for a total authorized amount of \$69,000.
3. It is estimated that work on this matter will be in excess of the currently authorized amount, so it is necessary to authorize an extension to the legal services agreement in the amount of \$25,000.

NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to extend Legal Service Agreement No. 32278, dated May 21, 1999, to provide for representation by outside counsel in an additional amount of \$25,000, for a total amount not to exceed \$94,000.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- c. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement chargeable to Center Code 57235222/Account 521000.

Section 2. The Council declares that an emergency exists in order to pay for legal services necessary in the matter of Lishey v City (litigation); therefore, this ordinance shall be in full force and effect from and after its passage by Council.
