

*Pay claim of Ron Sasse. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Ron Sasse, through his lawyer, has filed a lawsuit for damages he incurred arising out of a motor vehicle accident with a City employee on September 4, 1986.
2. The lawsuit has been investigated by the Risk Management Division and the City Attorney's Office. There is risk that the City might be found liable. Therefore, in order to avoid the risk of unknown damages and further defense costs, we feel it is prudent to settle the lawsuit.
3. The Risk Management Division recommends that the lawsuit be settled for \$75,000.00, subject to the plaintiff providing the City with a Release in a form to be approved by the City Attorney.

NOW, THEREFORE, The Council directs:

- a. The Mayor and Auditor are authorized to draw and deliver a warrant, in the amount of \$75,000.00, made payable to Ron Sasse and Willard Merkel, Attorney at Law, as settlement in full of any and all claims.
- b. The Risk Management Division will execute a payment authorization, in the amount set forth in subparagraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
