

ORDINANCE No.163737

Revise the tonnage fee that is billed to refuse collection permittees for the purpose of funding the City recycling program (Ordinance; amend Section 17.102.055 of the Code.)

The City of Portland ordains:

Section 1. The Council finds:

1. The City administers a multi-material recycling collection program that is mandated by state law and City recycling activities are funded by a tonnage fee that is billed to waste haulers based on the solid waste they collect within the City of Portland Urban Services Boundary.
2. To increase public participation in recycling, City recycling program activities will be expanded in the areas of neighborhood recycling outreach and apartment recycling.
3. The expenditures of the FY 1991 recycling program budget will require an increase in the tonnage fee that is billed to waste haulers.

NOW, THEREFORE, the Council directs:

- a. That Section 17.102.055 of the Code be amended to read as follows:

17.102.055 Tonnage Fee.

[(Added by Ordinance No. 15928, March 26, 1987.)] Effective [September 1, 1989,] February 1, 1990, permittees shall, when billed by the Bureau of Environmental Services, pay a tonnage fee of [\$1.35] \$2.35 per ton of solid waste collected within the City of Portland Urban Services Boundary and deposited in disposal facilities authorized by the Metropolitan Service District. The payment shall be made within 15 days of receipt of billing.
