

Solutions to funding challenges in the South Waterfront Urban Renewal Area SUBJECT:

There have been considerable discussions, negotiations and other efforts by many individuals and groups regarding how best to address the funding challenges in the South Waterfront District.

These discussions have resulted in a number of suggested ways to solve the apparent funding challenges of this rapidly developing area of the City - tram, affordable housing, streetcar extension, improvements to the recently Portland Development Commission (PDC)-acquired park lands, and the Greenway.

We are writing to direct PDC to serve as the City's agent on negotiations at this stage of the discussion to resolve this shortfall and other related issues. As the City's agent, PDC shall reach agreement with our partners in the district that includes guaranteed funding for:

- Tram completion:
- Streetcar extension:
- Affordable housing;
- Neighborhood park improvements; and
- Greenway improvements.

8th Amendment Components

- Funding for Portland Aerial Tram
 – lump sum contract with Kiewit
- Funding for acquisition of three to five affordable housing sites (over 1000 unit potential) and construction of first 200-unit project
- Funding for design/construction of greenway and neighborhood park
- Funding for Bio-Science Industry Initiative
- Funding for Streetcar extension to Lowell

- A. Funding and Timing
 - Cash Flow/Project Expenditure Adjustments
 - Project Schedule Adjustments
 - Additional Project Investment of \$55.3 M, including \$38.2 M of TIF
- B. Modifications to Local Improvement District by City
 - LID Finance Charge Reduced Citywide From 1.25% to 0.25%
 - LID Financing Flexibility
- C. Development Financing Commitments
 - OHSU TIF Generation-- Parking Garage Partial TIF Reinvestment
 - NMI Gap Payment Obligation—\$34.7 M


