

The Police Bureau has an agreement with the Multnomah County District Attorney's Office (DA) to provide three officers to perform investigations for the DA. The officers participate in investigations directly and indirectly related to the prosecution of crimes within Multnomah County's jurisdiction. The City will continue to bill Multnomah County District Attorney's Office quarterly for the equivalent of 7.3 hours of overtime for each of the officers per pay period. The maximum amount to be received under this agreement for the period of July 1, 2009 to June 30, 2010 is \$29,139.08.
