

ORDINANCE NO. 183440

Authorize the Portland Water Bureau to execute grants to fund the installation of high-efficiency toilets in low-income multi-family buildings (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland Water Bureau, through the Water Conservation Program, provides water conservation information and technical resources to all of its customers. The main objective of the conservation program is to help customers use water efficiently and cost effectively.
2. The Multifamily Toilet Replacement Grant will fund low-income housing providers to upgrade toilets. Providing a financial incentive for toilet fixture replacement with high-efficiency toilet models that flush with 1.28 gallons per flush will provide significant water and cost savings for organizations that often have limited resources for building upgrades.
3. Multifamily housing providers receiving a grant will be chosen by a selection committee consisting of representatives from the low income housing community and representatives from Customer Services and the Conservation Program of the Portland Water Bureau.
4. The Water Bureau has budgeted to pay \$40,000 in FY 2009-2010 and intends to request an additional \$40,000 per fiscal year in FY 2010-2011 and FY 2011-2012 Budgets. The grant agreement will not exceed \$120,000 and will be charged to cost center WARP000003.


NOW, THEREFORE, the Council directs:

- a. The Portland Water Bureau Administrator and Auditor are authorized to execute grants, substantially in the form of the agreement attached as Exhibit A, not to exceed a total of \$40,000 in FY 2009-2010 and \$40,000 per fiscal year in FY 2010-2011 and FY 2011-2012.
- b. That the Commissioner-in-Charge and Auditor are hereby authorized to pay for said grants that fund community partners managing low-income multifamily residences to replace existing toilets that flush at a rate of 1.6 gallons per flush or greater with High-Efficiency Toilets with a flush rate of 1.28 gallons per flush.
- c. Amendments increasing the total grant fund allocation, for any grant, may be executed by the Portland Water Bureau Administrator up to twenty-five percent of any specific grant agreement amount. Any increase exceeding twenty-five percent of any specific grant agreement of the total compensation would need City Council approval.
