In April 2006, the City of Portland Council passed Resolution No. 36423 establishing goals for the solid waste and recycling system, including a 75% recycling rate by 2015.

The Department of Environmental Quality offers grants to local jurisdictions to encourage recycling and waste prevention. This grant will allow Tabor Consulting to expand their sustainable practices. This will increase diversion that will positively affect our overall recycling goals.
