The City of Portland ordains:

Section 1. The Council finds:

1. Fireman's Fund Insurance Company, in cooperation with Toy N Joy Makers, donated five (5) Dell Inspiron 15, laptops to Portland Fire & Rescue, for use by Fire Officers in the field.
2. The approximate value of the laptop computers is \$2,500.
2. The Fire Chief recommends that the Council accept the donation from Fireman's Fund Insurance Company and Toy N Joy Makers.

NOW, THEREFORE, the Council directs:


- a. The City Council accepts the donation of the five laptop computers and thanks Fireman's Fund Insurance Company and Toy N Joy Makers for their donation.
