

ORDINANCE No. 183512

*Authorize a contract with the lowest responsible bidder for the Fanno Basin Pump Station Pressure Line, Garden Home Section Replacement Project No. E09115 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has a need to replace the Garden Home Section of the Fanno Basin pump station pressure line, BES Project Number E09115.
2. The replacement of the Garden Home Section is required to increase the flow conveyance capacity needed to convey peak flows during a 5-year storm event, and to remove the existing high density polyethylene (HDPE) piping that has been determined to be inadequate for long term reliable operations.
3. The level of confidence in the estimated cost for the replacement of the Garden Home Section of the Fanno Basin pressure line is moderate.
4. The estimated construction cost is \$ 5,500,000. Funds are available in the Sewer System Operating Fund FY 2010 Budget, Bureau of Environmental Services Project Number E09115.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs and Auditor are authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the failure of the Fanno Basin Force Main represents a risk to human health and the environment; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
