

ORDINANCE No. 183520

*Accept a grant in the amount of \$2,500 from The Department of Human Services Regional Offices on Women's Health for activities and events in support of National Women's Health Week in May 2010. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. Commissioner Amanda Fritz's office applied to The Department of Human Services Regional Offices on Women's Health for a grant in the amount of \$2,500 for activities and events in support of National Women's Health Week (NWHW) on December 8, 2009.
2. The Department of Human Services Regional Offices on Women's Health has notified the City of Portland that it will award a grant for National Women's Health Week to Commissioner Fritz's office in the amount of \$2,500.
3. NWHW is a national effort by government organizations to raise awareness about manageable steps women can take to improve their health, while emphasizing the importance of incorporating preventive and positive health behaviors into everyday life.
4. Funds for this grant will be used, in partnership with community organizations, to organize and provide workshops focused on preventative health care for homeless women in our community and nutrition education classes for women in transitional housing.
5. Partnership organizations that provide services to women living outside will include: Dinner and a Movie, Rose Haven Women's Shelter, Home PDX, and Salvation Army Female Emergency Shelter (SAFES).
6. No match is required by this grant.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Department of Human Services Regional Offices on Women's Health for National Women's Health Week in the amount of \$2,500.
- b. The FY 2009/2010 budget is hereby amended as follows:


