

# ORDINANCE No. 183521

Authorize the name of Play Haven Park for the property formerly known as Terrace Trails Park (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:


1. In 2001, Portland Parks & Recreation (PP&R) acquired land in the Terrace Trails subdivision in SE Portland to be set aside for a new park.
2. At the time of the acquisition, the park was not officially named, but was referred to as Terrace Trails Park because of its location in the Terrace Trails subdivision.
3. PP&R began a planning process for the park site in May 2008. An advisory committee was selected, open houses presented the design to the community, and construction was begun. Completion of the park is scheduled for the summer of 2010.
4. PP&R received a formal request from Kylie Holstrom on March 5, 2009 to name the park site, informally known as Terrace Trails Park, Play Haven Park. The name was requested to honor the former use of a large portion of the park site which was operated as a day camp and swim center for many years by Glen and Joan Wilcox.
5. In accordance with their Naming/Renaming of Parks and/or Recreational Facilities policy, adopted on May 2, 2007, PP&R convened a naming committee on October 6, 2009 to consider Ms. Holstrom's request. The naming committee has recommended that the property be formally named Play Haven Park; this name has also been approved by the Director of Portland Parks & Recreation and the Commissioner-in-Charge.

NOW, THEREFORE, The Council Directs:

- a. The Director of Portland Parks & Recreation is authorized to accept "Play Haven Park" as the name for the park in SE Portland formerly referred to as "Terrace Trails Park."
