

ORDINANCE No. 183577

*Authorize a \$105,222 grant agreement with the Center for Intercultural Organizing as part of the Diversity and Civic Leadership Academy for the period December 17, 2009 through June 30, 2010 (Ordinance)

The City of Portland Ordains:

Section 1. The Council Finds:

1. The City of Portland recognizes policy, planning and budget processes are best served when developed with public input representing a diverse cross-section of Portland's increasingly diverse communities.
2. This project, now in its third year, is one of several new initiatives within the Office of neighborhood Involvement (ONI) that provide the framework for the City's public involvement efforts and neighborhood system to better serve and engage traditionally under-represented groups in civic governance of the City.
3. The outcome of these projects is resulting in new community leaders having an expanded understanding of the City's governance structure, improved communications and expanded public involvement opportunities with City bureaus, and new partnerships between community of color as well as immigrant and refugee organizations.
4. Funds for the grants are included in the FY 2009-10 ONI budget as previously approved by Council.

Now therefore, the Council Directs:

- a. The ONI Director is authorized to enter into a grant agreement with the Center for Intercultural Organizing on behalf of the City for the period December 17, 2009 through June 30, 2010 in a form substantially in accordance with attached Exhibit A.
- b. Amendments to the grant agreement may be agreed to and executed by the City's Project Manager or his/her designee.
- c. Commissioner Fritz and the City Auditor are hereby authorized to pay for said grant agreement from the Office of Neighborhood Involvement general funds.

Section 2. The Council declares an emergency exists in order to expedite implementation of this project, therefore, this ordinance shall be in full force and effect from and after passage by Council.
