

ORDINANCE No. 183624

*Create ten new Nonrepresented classifications in housing-related occupations and establish compensation rates for these classifications. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating ten new non-represented classifications and establishing compensation rates for these classifications effective April 1, 2010.

- a. The following classifications are being created:


