*Amend the Intergovernmental Agreement with Port of Portland so that the Port may perform purchase obligations and to extend the time period for the distribution of equipment, supplies and services procured as a result of Urban Areas Security Initiative Grant FY 2009. (Ordinance; amend Contract No. 30000150)

2) Purpose of the Proposed Legislation:

The purpose of this legislation is to amend an Intergovernmental Agreement with our UASI regional partner, Port of Portland, Oregon. Port of Portland is one of seven agencies that participate in the Urban Areas Security Initiative grant program. The other participating agencies are Clark County/Washington, Clackamas, Washington, Columbia, Multnomah County and Tri-Met. Grant funds are for the purchase and distribution of equipment, supplies and services procured as a result of Urban Areas Security Initiative (UASI) Grants. The amended IGA's will add the FY 2009 UASI award for \$6,581,436 to the UASI regional program to allow authorized purchasing by the County and extend the IGA's to April 30, 2012.

7. BACKGROUND/ANALYSIS

This ordinance is presented and requested as an Emergency Ordinance so as to maximize the grant award period of performance. The Intergovernmental Agreement is designated for a specific period of time for the procurement of equipment, regional training, planning and exercising to be funded by the Urban Areas Security Initiative Grant Program (UASI).

The City of Portland entered into Intergovernmental Agreements with seven UASI agencies that make up the Portland Area UASI region, which includes Port of Portland. Grant funds are for the purchase and distribution of equipment, supplies and services procured as a result of Urban Areas Security Initiative (UASI) Grants. The IGA's are set to expire at the end of the FY 2008 grant period. The FY 2003, FY 2004 and FY 2005 grant periods are now closed. The amended Port of Portland IGA's will add the UASI 2009 award for \$6,581,436 to the UASI regional program and extend the IGA's to April 30, 2012; in order to procure goods and services under the FY 2009 grant award period.

Regional partnerships and MOU's have previously been established with Multnomah, Washington, Clackamas, and Columbia, Counties of Oregon and Clark County of Washington and are key to the UASI process and philosophy. Also in partnership, are the Port of Portland, Tri-Met, public health agencies within each county, and the disciplines of fire, police, public works, emergency communications, and emergency management.

8. FINANCIAL IMPACT

The City of Portland administers this grant on behalf of the UASI region. Portland receives 3% of the total UASI grant award for grant administration.
