

ORDINANCE No. 183693

Authorize a contract and provide for payment for the construction of the NE 60th Ave & Klickitat Sewer Replacement and Rehabilitation Project No. E08908 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Combined sewer pipe in NE 60th Avenue, from Klickitat Street down to Brazee Street, is in a seriously deteriorated condition and needs to be replaced.
2. Environmental Services has prepared plans and specifications for replacing the deteriorated sewer pipe including replacing manholes, service laterals, stormwater inlets and inlet leads.
3. Environmental Services requires the furnishing of materials and labor for this project.
4. The estimated cost is \$5,000,000. The level of confidence in this estimate is high. Funds are available in the Bureau of Environmental Services Sewer System Operating Fund, FY 2009-2010, Project No. E08908.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs and Auditor are authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1, in the amount of \$5,000,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
