*Authorize grant agreement with United Way of the Columbia-Willamette in the amount of \$25,000 to support outreach efforts for the 2010 Census (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

1. Support for increasing the participation in the 2010 Census of traditionally underrepresented communities, including homeless persons and other difficult to count subgroups of the population, is a priority of the City of Portland.

2. In coordination with Multnomah County and the United Way of the Columbia Willamette, the City will support efforts to partner with community agencies to outreach to homeless and under-represented communities to encourage their participation in the 2010 Census.

3. The 2010 Complete Count Committee is co-chaired by Commissioners Nick Fish and Deborah Kafoury and includes a broad range of community leaders.

4. The 2010 Complete Count Committee formed a sub-committee to provide mini-grants to community-based organizations to support culturally specific outreach for the 2010 Census.

5. The United Way of the Columbia Willamette will administer grant funding from the City and other funders for the mini-grants program.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-charge and Auditor are hereby authorized to enter into a grant agreement with United Way of the Columba Willamette with the agreement attached as Exhibit A.
- b. The mayor and City Auditor are hereby authorized to pay for said contract from the General Fund.

Section 2. The Council declares that an emergency exists because delay in funding would interrupt the United Way of the Columbia Willamette's ability to provide funding to community partners; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
