

ORDINANCE No. 183737

Amend contract administered by the Bureau of Human Resources, Benefits and Wellness Office with United Behavioral Health for employee assistance services effective July 1, 2010 through June 30, 2011 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Office of Management and Finance, Bureau of Human Resources requires the continuing provision of employee health and welfare administration as provided under PCC Section 5.33.220.
2. In order to maintain the employee assistance program service agreement it is deemed appropriate and necessary to implement the following contract amendment effective July 1, 2010 as attached in the following Exhibit
 - a. United Behavioral Health for Employee Assistance Services (EAP) services effective July 1, 2010 through June 30, 2011.

The Health Fund Budgets for FY 2010-11 include appropriations in support of the benefit related contracts listed above.

NOW THEREFORE, the Council directs:


