

ORDINANCE No. 183744

Authorize a contract and provide for payment for the construction of the NW Wilson Sewer Replacement Project No. E08962 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Approximately 4,000 feet of combined sewer main in and around the Northwest neighborhood is in a seriously deteriorated condition and needs to be replaced.
2. Environmental Services has prepared plans and specifications for replacing the deteriorated sewer pipe including replacing manholes, service laterals, stormwater inlets and inlet pipe.
3. Environmental Services requires the furnishing of materials and labor for this project.
4. The established cost is \$ 1,500,000. The level of confidence in this estimate is high. Funds are available in the Bureau of Environmental Services Sewer System Operating Fund, FY 2009-2010, Project No. E08962.


NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs and Auditor are authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1, in the amount of \$1,500,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
