7. BACKGROUND/ANALYSIS

Ernest Henderson is the owner of a fully restored classic car, a 1972 Buick Skylark, which was legally parked at the curb along North Argyle Street on September 13, 2009. On that date, a Portland Parks Bureau equipment operator, driving a City vehicle, lost control of his truck, and forcefully rear-ended Mr. Henderson's vehicle, pushing it approximately 30 feet forward and up over the curb. The resulting damage rendered the Skylark a total loss. Mr. Henderson used his own insurance coverage to cover this loss, and Nationwide Insurance now presents their demand to the City, seeking reimbursement of \$11,535 that has been paid to Mr. Henderson. Additionally, Mr. Henderson incurred rental car charges of \$167.88. Risk is requesting two checks totaling \$11,702.88 be issued to settle this damage claim.

The City driver is solely responsible for these damages, and approval of this ordinance will allow Risk Management to resolve the claims of Mr. Henderson and Nationwide Insurance.

8. FINANCIAL IMPACT

Approval of the settlement would result in a payment of \$11,702.88 from the liability fund.
