

ORDINANCE NO. **183814**

* Amend subrecipient contract with Impact Northwest to add \$20,000 for relocation services.
(Ordinance; amend Contract No. 30000578)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The Portland Housing Bureau (PHB) is committed to assisting low-income households in the City of Portland to relocate from substandard housing.
2. PHB currently has a contract with Impact Northwest (formally known as Portland Impact) to provide the relocation services to low-income renter households.
3. PHB desires to increase the contract budget by \$20,000 in Community Development Block Grant (CDBG) for a revised total compensation not to exceed \$128,570 for serving additional households referred to the relocation program.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and City Auditor are hereby authorized to amend Subrecipient Contract No. 30000578 with Impact Northwest in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2009-10 budget when demand is presented and approved by proper authority.

SECTION 2. The Council declares that an emergency exists because delay in funding would interrupt Impact Northwest's ability to provide relocation services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
