The City of Portland ordains:

Section 1. The Council finds:

- 1. On February 9, 2009, the City entered into a Professional, Technical, or Expert Services Contract No. 30000272 ("Agreement") with Summit Design/Fran Kievet for graphic design work for Portland Parks & Recreation's (Parks) Aquatics program.
- The original Agreement amount was \$23,000, with an expiration date of February 9, 2. 2010.
- On January 15, 2010 the Agreement was extended for one additional year by 3. Amendment No. 1, but the dollar amount of the contract was not changed.
- Summit Design is utilized by Parks for their Summer and Fall Aquatic program 4. brochures, Aquatic Staff training and orientation manuals, summer program flyers and program manuals for the Summer swim league, Jr. Lifeguard and Jr. Swim Instructor programs.
- Summit Design has begun work needed to support Aquatics summer programs and 5. Parks wishes to amend the amount of the Agreement to allow Summit Design to complete this work.
- Parks requests that Amendment No. 2, which increases the contract amount by 6. \$20,000, be approved. The additional funds are included in the FY09-10 Park's budget.

NOW, THEREFORE, The Council Directs:

- The Commissioner in Charge of Parks or the Chief Procurement Officer is a. authorized to amend Contract No. 30000272 with Summit Design/Fran Kievet to increase the contract amount by \$20,000.
- The Commissioner and Auditor are hereby authorized to draw and deliver checks b. when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists to avoid further delay in the provision of on call graphic design services which are needed immediately to support summer programming; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
