

## ORDINANCE No. 183843

Authorize contract and provide for payment for the construction of the SW Yamhill Street from SW 10<sup>th</sup> Ave. to SW 11<sup>th</sup> Ave. Sewer Replacement Project No. E10024 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has a need to replace a sewer main in SW Yamhill Street from SW 10<sup>th</sup> Avenue to SW 11<sup>th</sup> Avenue.
2. The established construction cost is \$1,207,000. The level of confidence of the estimated construction cost is Optimal. Funds are available in the Sewer System Operating Fund, FY2010 Budget, Bureau of Environmental Services, WBS Element E10024.C14.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs and Auditor are authorized to execute a contract with the lowest responsive bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


