1) <u>Legislation Title:</u> *Authorize grant agreements and intergovernmental agreements with fifteen non-profit and public entities related to the Community Watershed Stewardship Program.

2) <u>Purpose of the Proposed Legislation</u>:

Fund community partnerships to implement small on-the-ground restoration and education projects. These diverse projects will de-pave impervious surface, create bioswales, naturescape landscapes, build community gardens and restore streamside areas while teaching the community about what individuals can do to improve watershed health.

Immigrant and Refugee Community Organization (IRCO) Gilbert Park Native Garden (\$4,006), Friends of Crystal Springs Creek Restoration (\$3,900), Friends of Tideman Johnson Park Restoration (\$4,800), Lents Springwater Habitat Restoration (\$9,900), Leach Botanical Garden Riparian Restoration (\$5,200), Columbia Slough Watershed Council Eyes on the Slough Project (\$3,750), Oregon Humane Society Natural Area Restoration (\$5,400), Colonial Heights Presbyterian Church Raingarden (\$4,840), Glenfair Church Community Garden (\$9,995), Friends of Marquam Nature Park Trailhead Improvements (\$4,215), Tabor Commons Stormwater Planter (\$8,294), Laurelhurst School Stormwater Education (\$2,600), Tryon Creek Watershed Council Mentor Project (\$7,300), Vermont Hills United Methodist Church Community Garden (\$4,000), and PCC Sylvania Natural Area Habitat Restoration (\$6,100).

I. RECOMMENDATION

*Authorize grant agreements and intergovernmental agreements with fifteen non-profit and public entities related to the Community Watershed Stewardship Program.

II. BACKGROUND

Local organizations have been participating in the city's Community Watershed Stewardship Program since 1995 as recipients of various grant contracts for projects throughout the watersheds. Since 1995 the program has granted \$802,363 to 183 projects. As of early 2009, these funds were matched by over \$2.4 million in community support through donations of services, materials and volunteer time. Over 32,800 people have donated 293,127 volunteer hours, planted 95,737 native plants and trees, restored over 50 acres of riparian and upland habitat, and enhanced over 25,919 linear feet of streams. Community Watershed Stewardship projects can be found along streams and sidewalks, in parks, schoolyards, church parking lots, below downspouts and even up on roofs.

The primary elements of the program are education, watershed improvements, evaluation and documentation of progress, school curriculum based watershed involvement, and technical/financial support to citizens. This year's projects include: Immigrant and Refugee Community Organization (IRCO) Gilbert Park Native Garden (\$4,006), Friends of Crystal Springs Creek Restoration (\$3,900), Friends of Tideman Johnson Park Restoration (\$4,800), Lents Springwater Habitat Restoration (\$9,900), Leach Botanical Garden Riparian Restoration (\$5,200), Columbia Slough Watershed Council Eyes on the Slough Project (\$3,750), Oregon Humane Society Natural Area Restoration (\$5,400), Colonial Heights Presbyterian Church Raingarden (\$4,840), Glenfair Church Community Garden (\$9,995), Friends of Marquam Nature Park Trailhead Improvements (\$4,215), Tabor Commons Stormwater Planter (\$8,294), Laurelhurst School Stormwater Education (\$2,600), Tryon Creek Watershed Council Mentor Project (\$7,300), Vermont Hills United Methodist Church Community Garden (\$4,000), and PCC Sylvania Natural Area Habitat Restoration (\$6,100).
