The U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) will provide grant funding for the purchase of bulletproof vests for local law enforcement agencies. The City wishes to apply for grant funding for bulletproof vests for 100 law enforcement officers whose vests are due for replacement during the next two years.
