**1) Legislation Title:**

\* Authorize an Intergovernmental Agreement with Multnomah County for the use of funds from the Edward Byrne Memorial Justice Assistance Grant (JAG) Program FY 2010 Local Solicitation (Ordinance)

**2) Purpose of the Proposed Legislation:**

To enter into an Intergovernmental Agreement in which the City will serve as fiscal agent and Multnomah County will be a sub-recipient for FY 2010 program funding. The Agreement will obligate agency roles and responsibilities of both parties. The 2010 JAG grant application required the City to serve as the fiscal agent for Multnomah County agencies that receive funding.

**3) Revenue:**

The grant award is \$824,764. The City will serve as the "pass-through" agency for FY 2010 JAG program funding awarded to the sub-recipients. Multnomah County will receive \$318,723 and the City of Gresham will receive \$100,392.

The U.S. Department of Justice will reimburse the City a maximum of \$824,764 for allowable grant program expenses.
