*Accept a grant in the amount of \$143,973 from Lower Columbia River Estuary Partnership for Tryon Creek Confluence Habitat Enhancement (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Lower Columbia River Estuary Partnership (LCREP), in partnership with National Oceanic and Atmospheric Administration (NOAA), has notified the City of Portland that it will award a federal grant for Tryon Creek Confluence Habitat Enhancement to BES in the amount of \$143,973

NOW THEREFORE, the council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from Lower Columbia River Estuary Partnership (LCREP) for Tryon Creek Confluence Habitat Enhancement in the amount of \$143,973 and to execute a grant agreement in substantially the form of the attached exhibit for this purpose.
- b. The FY 2009/2010 budget is hereby amended as follows:

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
