

ORDINANCE NO. 183958

* Authorize application to the U.S. Department of Justice, Office of Community Oriented Policing Services FY 2010 Child Sexual Predator Program for a grant in the amount of \$489,648 to locate, arrest and prosecute child sexual predators (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Department of Justice (USDOJ), Office of Community Oriented Policing Services (COPS) has nominated the City of Portland, Police Bureau to apply for grant funding. Approximately \$10.2 million in funding is available under CSPP for law enforcement agencies to establish and/or enhance strategies to locate, arrest, and prosecute child sexual predators and exploiters, as well as enforce state sex offender registration laws.
2. The City wishes to apply for grant USDOJ/COPS CSPP funding to ensure victim and community safety through effective enforcement/management/supervision of Child Sexual Predators.
3. The USDOJ will reimburse the Bureau for personnel, equipment and training expenses not to exceed the grant application request of \$489,648. The grant period is October 1, 2010 through September 30, 2012. This grant does not require a match.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the U.S. Department of Justice, Office of Community Oriented Policing Services for a grant in the amount of \$489,648.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because delay in proceeding with this application may result in not receiving funding. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
