**1) Legislation Title:**

\* Authorize an intergovernmental agreement between the City, the Tri-County Metropolitan Transportation District and the City of Hillsboro (Ordinance)

**2) Purpose of the Proposed Legislation:**

It is the intent of this agreement to assign one or more Hillsboro Police Officers to Transit Police. Transit Police is managed by the Portland Police Bureau, and staffed by officers from several jurisdictions. Hillsboro will pay the salaries, overtime, insurance, retirement and other benefits and indirect (overhead) charges. Hillsboro will invoice TriMet for services provided by the City of Hillsboro. Future staffing levels may be adjusted by agreement of the City of Portland, City of Hillsboro and TriMet under the authority of the commander of the Transit Police Division.

There is no cost to the City as TriMet will reimburse the City of Hillsboro directly for all related expenses of its officers that are assigned to the Transit Police Division.


