7. BACKGROUND/ANALYSIS

The Purpose of the Proposed Legislation is compliance with Oregon OSHA's law requiring employees exposed to high noise level averages at or above 85 decibels in the workplace to have their hearing tested and receive appropriate training annually.

The City of Portland has had an ongoing Hearing Conservation Program since the 1980's. Since then we have continued to contract for outside Hearing Conservation Program Services for employees included in the Hearing Conservation Program. There are approximately 1500 employees currently included in the citywide program.
