

ORDINANCE NO. 184012

* Authorize subrecipient contracts totaling \$8,523,392 for services to further the goals of the Portland Housing Bureau through the 10-Year Plan to End Homelessness and provide for payment. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. On any given night in Portland/Multnomah County, an estimated 2,500 men, women and children must sleep on the streets or in shelters because they lack a safe place to call home.
2. In December 2004, leaders and citizens of Portland/Multnomah County launched "Home Again – A 10-Year Plan to End Homelessness in Portland and Multnomah County."
3. Since the 10-Year Plan's inception, the City of Portland, acting through its Portland Housing Bureau (formerly the Bureau of Housing and Community Development), has been a major funder of the key strategies and services of the 10-Year Plan.
4. The Portland Housing Bureau's Ending Homelessness Initiative contracts are solidly aligned with the goals of the broader community's 10-Year Plan.
5. Funded programs and services have a demonstrated record of success and effectiveness in moving our community towards the bigger goal of ending homelessness.
6. It is the Portland Housing Bureau's intent to continue funding successful and effective programs at the funding levels identified in Exhibit A that exceed \$100,000.
7. Carry-over funds from FY 09-10 were encumbered for FY 10-11 in the Spring BuMP and are available in the FY 2010-11 adopted budget with additional appropriations not to exceed \$8,523,392 through City General Funds and the following U. S. Department of Housing and Urban Development (HUD) programs: Supportive Housing Program (SHP), HOME, Emergency Shelter Grant (ESG), Community Development Block Grant (CDBG), as well as federal stimulus Homelessness Prevention and Rapid Rehousing (HPRP). Funds will be used to provide rent assistance, shelter and transitional housing, and other services to support transitions from homelessness to housing.

NOW THEREFORE, the Council directs that:

- a. The Bureau Director and City Auditor are authorized to execute agreements with the organizations and for the amounts in substantially the form of Exhibit B attached hereto, for the purpose described above.

- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Portland Housing Bureau's operating fund budget when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the program funds must be obligated within required timeframes; therefore, this ordinance shall be in force and effect from and after its passage by Council.
