We had over 20 neighbors send a letter to the city about the fence. They wanted to put a wood 6 fool tall fence on top of the 12 foot wall.


We have all agreed that a retaining wall should have a set back after 4 feet.

Thank you for the opportunity to comment on the RICAP 5b proposal. In general, PMA is supportive of the code amendments in question. We do have one comment regarding Item 5, Historic Design Review for Vents.


**Bureau's proposal**: Vents on non-street-facing facades and on flat roofs are proposed to be allowed without historic design review if certain restrictions are met. These include a height limitation based on setback for roof applications, an area restriction for the vent itself, a limitation on location with regards to existing features, and a paint (color) requirement.

**Counter-proposal**: For wall applications, the majority of vents will be flush to the face of wall, but some have vent covers or the vent itself projects from the wall. Therefore we propose a simple limitation on the amount of projection allowed without review. Specifically, we propose the following clause (or similar language) to be added:

- The vent and any associated elements such as a cover must not project more than 6 inches from the finished surface in its installed location.

On June 22, 2010, the Portland Planning Commission held a hearing on the Regulatory Improvement Code Amendment Package 5b (RICAP 5b). The package covers minor amendments to the Zoning Code in seven areas, including two items referred back to the Commission by City Council after the RICAP 5 hearing in March. No testifiers attended the Planning Commission's hearing, but we received one letter supporting new standards for retaining walls.
