

**ORDINANCE No. 184041**

\*Authorize a grant agreement with Roosevelt High School Booster Club related to improvements to Roosevelt High School sports fields (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds that:

1. The City and the Theodore Roosevelt Athletics Complex (TRAC) Project of Roosevelt High School Booster Club are authorized to enter into a Grant Agreement.
2. Research shows that sports are a powerful tool in preventing obesity, crime and drug use, and promoting academic achievement and pro-social behavior among youth.
3. The City has made previous contributions to TRAC Great Fields initiative as well as recreational and open spaces in East Portland school districts.
4. The City and TRAC recognize that providing access to suitable sports fields for Portland residents is a valuable component of overall neighborhood livability.
5. The St. Johns TRAC is designed to accommodate significantly more user hours than available on the current facility which will allow a broad array of recreational and competitive sports programs and activities from throughout the geographic area.
6. The City Council appropriated funds for this purpose in the Fiscal Year 2010-11 Adopted Budget Special Appropriations.
7. The Grant Agreement between the City and the Theodore Roosevelt Athletics Complex (TRAC) Project of Roosevelt High School Booster Club is attached as Exhibit A.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to enter into a Grant Agreement, as outlined in form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$200,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2010-11 Adopted Budget.


