

ORDINANCE No. 184067

Authorize contract with Vigil Agrimis, Inc. and provide for payment for the design and implementation of the Design Services for Sump Shallowing and Stormwater Facility Improvements Project No. E10114 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services pursued design and construction of Underground Injection Control (UIC) systems that comply with Department of Environmental Quality (DEQ) requirements for groundwater separation.
2. There is interest, Citywide, to construct greenstreet facilities.
3. A consultant selection process has been conducted and Vigil Agrimis, Inc. was selected to provide Design Services for Sump Shallowing and Stormwater Facility Improvements.
4. M/W/ESB participation on this contract is 100%.
5. The estimated cost of this contract is \$391,506. Funds are available in the Sewer System Operating Fund, FY 2010-11 Budget, BES Project No. E10114.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with Vigil Agrimis, Inc. in a form substantially in accordance with the attached contract as Exhibit A, for the purpose described in Section 1, in the amount of \$391,506.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
