

## ORDINANCE No. 135236

An Ordinance amending Section 24.08.010 of the Code of the City of Portland, Oregon, relating to the Uniform Building Code reference contained therein.


The City of Portland ordains:

Section 1. The Council finds that Section 24.08.010 of the Code of the City of Portland, Oregon, adopts by reference the Uniform Building Code; that such reference should have included the appendix of said code; that it has been recommended by the Building Inspections Director and approved by the Mayor as Acting Commissioner in charge of the Bureau of Buildings, that said section be amended to include reference to said appendix; now, therefore, Section 24.08.010 of the Code of the City of Portland, Oregon, hereby is amended to read as follows:

24.08.010 UNIFORM BUILDING CODE, 1970 EDITION,  
VOLUME 1.

The provisions of the Uniform Building Code, 1970 Edition, Volume 1, including the appendix, published by the International Conference of Building Officials, three copies of which are on file in the office of the City Auditor, hereby are adopted by reference and such provisions shall apply within the City, except as to matters specifically covered by the provisions set forth in this title, and in all cases where specific provisions of this title apply such provisions shall control notwithstanding any contrary provisions of said Uniform Building Code.
