1) Legislation Title:

* Authorize grant agreement with the Immigrant and Refugee Community Organization for street level gang outreach from September 1, 2010 through December 31, 2010 (Ordinance)

2) Purpose of the Proposed Legislation:

In the 2010-11 budget the Office of Youth Violence Prevention (OYVP) received \$386,473 for 2010-11 to award as grant fund money. Immigrant and Refugee Community Organization employee(s) have performed Street Level Gang Outreach services during the course of 2 continuous grant agreement time periods, from May 2009 through August 2010. The basis of the grant agreement has been established due to the success in fulfilling the scope of work assigned under Grant Agreement No. 32000233 for Street Level Gang Outreach services from September 1, 2009 through August 31, 2010, the uniqueness and efficiency of their service delivery, and the benefit derived by City through the application of their services during the previous grant periods. The Ordinance authorizes \$16,371.22 for Immigrant and Refugee Community Organization to provide the previously described Street Level Gang Outreach for an additional term, September 1, 2010 through December 31, 2010.
