7. BACKGROUND/ANALYSIS

This Ordinance is to authorize settlement of a lawsuit brought against the City by Donna Milrany (Risk File No. G2006-0322). This settlement is subject to approval by the City Council. We are recommending the City pay a total of \$27,000.00 to settle the litigation.

The incident that led to this claim began in August, 2004, when Comfort Mechanical installed a new furnace in plaintiff's home. The City of Portland inspected and approved the installation in October, 2004, as part of the required permitting process. Both Comfort Mechanical and the City acknowledged that the installation was done incorrectly, in that the Comfort Mechanical installer failed to properly connect the exhaust vent, which is intended to ventilate exhaust gases from the furnace to the exterior of the home. As a result, plaintiff was possibly exposed to carbon monoxide discharge when the furnace was in use from the time of its installation in August 2004, to the time the problem was discovered in August 2005.

In a lawsuit filed in August 2006, Ms. Milrany claimed she suffered injuries due to exposure to carbon monoxide. A settlement conference was held in July 2010 with a Multnomah County Circuit Court Judge, at which the parties were finally able to reach a compromise total settlement of \$54,000: \$27,000 to be paid by the City and \$27,000 to be paid by the installer, Comfort Mechanical. This marked a significant decrease from all of plaintiff's prior demands. We recommend the City pay a total of \$27,000 to settle the lawsuit.

8. FINANCIAL IMPACT

Approval of the settlement would result in a payment of \$27,000.00 from the liability fund.
