Authorize a contract and provide payment for the construction components of the Stilling Basin Right Bank Improvements Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Water Bureau requires the construction of the Stilling Basin Right Bank Improvements Project as the right (North) bank of the Bull Run River at the location of the Dam No. 2 Spillway is not adequately armored to resist a 500-year flood event. The proposed armoring will protect Conduits No. 2 and No. 4 on the right bank of the Bull Run River for a 500-year flood event. In addition, the unsound rock weir downstream of the Dam No. 2 Spillway will be removed. This proposed action will open up a greater reach of the Bull Run River for fish passage and facilitate improvements in cold water releases for enhanced fish habitat downstream.
- 2. The engineer's estimate for this project is \$1,000,000 with a High Confidence Rating.
- 3. Funding for a portion of this project is included in the Bureau's FY 2010-11 Budget and additional funding will be requested in the FY 2011-12 Budget.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund Account 563300 when demand is presented and approved by the proper authorities.
