

ORDINANCE No. 184181

*Extend contract with Good Sport Promotion, Inc. for volunteer management and recruitment for Portland Sunday Parkway Program for one year and increase by \$98,750 (Ordinance; amend Contract No. 30001129)

The City of Portland ordains:

Section 1. The Council finds:

1. The Vision for the Portland Bureau of Transportation (PBOT) calls for a balanced, multi-modal transportation system where residents will have a broad range of safe and convenient transportation options and will frequently walk, bicycle, carpool, or ride public transit as their first choice of transportation.
2. Sunday Parkways is the concept of opening up a network of streets once a week to encourage healthy, active walking and cycling and has proven to be an effective means of promoting active transportation in several cities across the world. In 2010, five Sunday Parkways events drew over 91,000 participants and garnered significant media coverage.
3. The City of Portland and its partners plan to implement five Sunday Parkways events in 2011, which will promote walking and bicycling in Portland.
4. Good Sport Promotion, Inc. was selected through a competitive bid process to provide volunteer management and recruitment services for five Sunday Parkways in 2010.
5. The City is interested in having Good Sport Promotion, Inc. continue to provide these services and expand its role recruiting and activating sponsors. The City was satisfied with the contractor's performance.
6. The Bureau's level of confidence in the cost estimates for this project is high, and funds are included in Transportation's FY 10/11 and will be included in the FY 11/12 proposed budgets.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and Auditor are authorized to amend Contract No. 30001129 with Good Sport Promotion, Inc., to extend by one year and add \$98,750 in a form substantially in accordance with the amendment attached to the original of this ordinance and, by reference, made a part hereof.

Section 2. The Council declares that an emergency exists because the existing contract is set to expire on October 31, 2010 and the parties wish to continue providing volunteer management

and recruitment services without a gap in services; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
