

ORDINANCE No. 184313

- * Authorize Intergovernmental Agreement with Portland Community College CLIMB HP for ongoing Emergency Medical Services training (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. All Portland Fire & Rescue (PF&R) firefighters are Emergency Medical Technicians, either Basic or Paramedic.
2. The State of Oregon and Multnomah County require Continuing Medical Education courses on an ongoing basis in order to maintain EMT certification.
3. Portland Community College (PCC) provides Special Custom Designed Educational Services to meet the certification requirements.
4. PCC will provide Special Custom Designed Educational Services for a sum not to exceed \$60,000 every four (4) years specifically as described in Exhibit A, attached to this document.
5. PF&R has the funds for this training in its budget.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Safety and Auditor are authorized to execute an agreement with Portland Community College as outlined in a form substantially in accordance with the agreement attached hereto as Exhibit A, at a cost not to exceed \$60,000 every four (4) years.

Section 2. The Council declares that an emergency exists because the training needs to begin January 2010; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
