This Contract was made and entered by and between <u>Rick Hlavka DBA Green Solutions</u>, hereinafter called Contractor, and the City of Portland, a municipal corporation of the State of Oregon, by and through its duly authorized representatives, hereinafter called City.

This contract is hereby amended as follows:

- 1. Extend contract through January 31, 2012.
- 2. Appoint Megan Ponder as City's Project Manager for this project.

3. Amend Task 2 as follows:

In addition to 7 waste sorts already scheduled for yard debris/food scraps in January, conduct a total of 14 waste sorts on garbage and recycling in January and 63 waste sorts on garbage, recycling and yard debris/food scrap samples for April, July and September. Samples of 200-250 pounds shall be drawn from loads provided by waste hauling companies participating in the pilot program. Contractor shall coordinate with waste hauling companies and facility operators to make arrangements for conducting the waste sorts according to the following schedule:

4. Amend Task 3 as follows:

- 1. Additional Reports: Contractor shall prepare and submit to the City draft reports for sorts conducted in January, April, July and September. Draft reports shall contain numerical results as well as a description of the process and analysis of the results. Reports shall be due on the following dates:
 - a. February 2, 2011
 - b. May 3, 2011
 - c. August 2, 2011

- d. October 4, 2011
- 2. Replace Task 3, Item 2. in its entirety with the following: Contractor shall prepare and submit to the City for review and comment a draft final report by October 14, 2011 that includes a description of the sort process and the results for each sorting period and any other information agreed upon by the contractor and the project manager. The final report shall be prepared and submitted by October 31, 2011. All digital photos, copies of field data collection forms and data entry spreadsheets shall be submitted with the final report.
- 5. Amend the COMPENSATION SCHEDULE to include:
