

ORDINANCE No. 184359

Authorize Portland Parks & Recreation to renew its sponsorship of an Oregon Department of Education Child Nutrition Program (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks & Recreation is a sponsor of an Afterschool At-Risk Meal and Snack Program, administered by the Oregon Department of Education's Child Nutrition Program. Through this program, children enrolled in afterschool education or enrichment programs receive free nutritious meals and snacks. Program sponsors are eligible for federal reimbursement of costs.
2. St. Johns Community Center and University Park Community Center are participating for the 2010-2011 school year.
3. In 2010, City Council approved Portland Parks & Recreation's sponsorship of the program, and the Bureau entered into a sponsorship agreement with the Oregon Department of Education.
4. The Oregon Department of Education requires sponsors to annually renew their sponsorship.
5. The 2010-2011 budget for this program is \$25,000, with \$24,000 projected in federal reimbursement monies.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Education for the Afterschool At-Risk Meal and Snack Program in the amount of \$24,000.
- b. The FY 2010/2011 budget is hereby amended as follows:
 - GRANTS FUND
 - Fund 217001
 - Business Area – PK00
 - Bureau Program Expenses – \$24,000
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
