This Amendment is made and entered into this 14th day of March, 2011 between Triad Technology Group hereinafter called "Contractor," and the City of Portland, a municipal corporation of the State of Oregon, by and through its duly authorized representatives, hereinafter called "City."

A. This Contract is hereby extended through December 31, 2011.

B. Additional work is necessary as described in the following Scope of Work:

SCOPE OF WORK

Provide project and transition management for the implementation of the Housing Development Software system selected through the Portland Housing Bureau (PHB) Affordable Housing and Development Core System RFP #112506. This system will replace and enhance the functionality currently provided by the shared Portland Housing Bureau/Portland Development Commission Mitas database instance.

- C. Additional compensation of \$113,000 is necessary, and the total revised contract budget shall not exceed \$162,500.
- D. All other terms and conditions of this contract shall remain unchanged and in full force and effect.

CONTRACTOR SIGNATURE:

This contract amendment may be signed in two (2) or more counterparts, each of which shall be deemed an original, and which, when taken together, shall constitute one and the same contract amendment.
