ORDINANCE No. 184528

*Authorize an Intergovernmental Agreement and ccept a grant in the amount of \$2,093,400 from the Oregon Department of Transportation for the Going to the River project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. Going to the River is a bundle projects that will provide seamless bicycle and pedestrian connections from North and Northeast Portland to Swan Island via the Going St. Bridge.
- 2. The Portland Bureau of Transportation applied to the Oregon Department of Transportation (ODOT) for a grant in the amount of \$ 2,093,400 for the Going to the River project on November 12, 2010.
- 3. ODOT has notified the City of Portland that it will award a grant for the Going to the River project to the Bureau of Transportation in the amount of \$2,093,400.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the Going to the River project in the amount of \$2,093,400 and to execute an Intergovernmental Agreement in substantially the form of the attached exhibit for this purpose.
- b. The FY 2010/2011 budget is hereby amended as follows

c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
