

ORDINANCE No 184553

Extend contract with Shiels Obletz Johnsen for Portland Traffic and Transportation Class for two years and increase amount by \$9,500 (Ordinance; amend Contract No. 38129)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Traffic and Transportation Class educates Portland residents about the city and regional transportation system while offering residents the opportunity to engage in a direct dialogue with Transportation managers and other transportation experts.
2. Shiels Obletz Johnsen was selected through a competitive bid process to lead the class for three years, beginning in 2008.
3. The City is interested in having Shiels Obletz Johnsen continue to provide this service for two additional years, through Fiscal Year 2012/2013.
4. The Bureau's level of confidence in the cost estimates for this project is high.

NOW, THEREFORE, the Council directs:

- a. That the Chief Procurement Officer and Auditor are authorized to amend Contract No. 38129 with Shiels Obletz Johnsen, to extend by two years and add \$9,500 in a form substantially in accordance with the amendment attached to the original of this ordinance and, by reference, made a part hereof.
