

ORDINANCE NO. 184590

*Accept a \$10,000 grant award from the National Recreation and Park Association to support the free lunch program in selected City parks. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks & Recreation has long been an advocate for summer lunch programs.
2. Beginning in 1906, the first summer playgrounds program was offered and PP&R has become a major partner in the effort to provide free summer lunches to children throughout the city.
3. Economic conditions have led the Portland City Council to reduce funding for this important program in 2011.
4. This grant award will allow PP&R to meet the need at all existing free lunch program park sites this summer.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept a grant from the National Recreation and Park Association \$10,000 to increase the number of free lunches given to children in need during the summer months in selected city parks.
- b. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists in order to avoid further delay in Portland Parks & Recreation receiving the grant funds; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
